

### SECTION 4: First aid measures

# 4.1. Description of first aid measures

#### General information

In the case of accident: Contact a doctor or casualty department – take the label or this safety data sheet. Contact a doctor if in doubt about the injured person's condition or if the symptoms persist. Never give an unconscious person water or other drink.

There are no exposure scenarios implemented for this product.

**Exposure limits** 

Professional users are subjected to the legally set maximum concentrations for occupational exposure. See occupational hygiene limit values above.

#### Appropriate technical measures

The formation of vapours must be kept at a minimum and below current limit values (see above). Installation of a local exhaust system if normal air flow in the work room is not sufficient is recommended. Ensure eyewash and emergency showers are clearly marked.

Apply standard precautions during use of the product. Avoid inhalation of vapours.
